



Hello, neighbors.

It's time for street repairs. Beginning July 6, Sweetens Concrete Service will replace damaged sections of Stonewater streets. In addition, sealing work will be done on all streets in July.

After evaluating street conditions, trustees decided to replace sections of Stonewater Drive and Living Water Court. Concrete will be removed, rock will be placed as a roadbed and reinforced concrete will be installed.

Repaired sections will be closed for one week as concrete cures. Repairs on Stonewater mean most residents must use Rolling Stone Boulevard to access Festus Horine Road.

Sweetens will post signs advising of the work. Parking will be prohibited in the repair zones.

Stonewater Drive replacement will be beyond the roundabout and will involve five slabs. This section is original to the subdivision and in use for more than a decade. Vehicular traffic and access by construction equipment took a toll.



The schedule: Removal work takes place on Tuesday, July 6, with concrete poured on July 7. Stonewater will reopen to through traffic on July 13.

On Living Water, four slabs will be replaced the week of July 12, with concrete removal one day, concrete pouring the next. Full access to Living Water will be available through the cul-de-sac. Again, repaired sections will be closed to traffic for one week.



Sweetens also will seal seams between slabs and cracks throughout the subdivision. This work will follow concrete replacement. Dates for sealing work will be announced later.

Sealing will stop water from seeping under slabs, preventing deterioration of the substrate and keeping existing surfaces intact longer. For more information, visit <https://sweetensconcrete.com/services/concrete-sealing/>

Trustees evaluated all Stonewater streets. Repairs to other streets will follow on an annual basis.

Money to cover repair costs comes from Stonewater homeowners' annual assessments.

Lake update

Herculaneum officials continue to work on plans to repair the main lake dam, where a breach exposed the main water and sewer supply lines into Stonewater. Work likely will begin in late summer during a prolonged dry period to allow solid ground for heavy equipment access.

Important recent developments include a plan to avoid access through Stonewater homeowners' property. City officials reached agreement with property owners between the dam and Herky Horine Road to allow access to the dam. This includes Liberty Country Club.

Phase 3

Work is well under way in the third section of Stonewater. There is an access drive that links Dogwood Lane to Stonewater Drive at the roundabout, and the section of Dogwood that connected to Festus Horine Road is now used as a construction entrance. **REMINDER:** Lots are posted and thus trespassing is prohibited, as it is on all homes under construction.

Last word

Recent rain eased fire concerns, but please be careful using fireworks during the Fourth of July weekend. **REMINDER:** Trash pickup will not be affected by the holiday.
