



Hello, neighbors.

Beginning Monday, Oct. 10, street repairs will begin in Stonewater. The following streets will be impacted: Rolling Stone, Waters Edge Way and intersections with Living Water and Waterfall Way.

**Please do not park on either side of the street within 50 feet of the work areas listed below.** This will allow access to the contractor and to service providers including school buses, trash, and public safety and emergency services.

Work will be done near:

- **1901 Rolling Stone**
- **1674 Waters Edge Way**
- **1709 Waters Edge Way**
- **1760 Waters Edge Way**, on Living Water adjacent to this address
- **1874 Waters Edge Way**, at the intersection with Waterfall Way



Workers will arrive about 7 Monday mornings, both Oct. 10 and 17, to begin removal of damaged concrete. Concrete will be poured on the following Tuesdays. Repaired areas are closed the remainder of the week to allow concrete to cure.

Until work is complete, please place trash bins on the opposite side of the street for pickup. Work should not involve the Oct. 17 pickup of recyclables.

During the repair and replacement, one lane of the streets listed above will be closed the first week. The second week, the opposite lane will be closed, if needed.

Expect to see no-parking signs at the work areas.

Sweetens Concrete will perform the work, as it did last summer.

Several damaged sections of Stonewater Drive will be repaired once construction equipment stops going into Phase 3 at Stonehedge Drive.

The following agencies have been notified about the repair:

- **Dunklin R-5 schools.** Bus pickup or dropoff times should not be affected.
- **Dunklin Fire district**
- **Joachim Ambulance district**
- **Waste Connections,** the city's trash and recycling hauler.

## Fountain fix

An aeration system will soon be in use at the retention pond along Rolling Stone at Watering Stone. Workers installed a pump, anchors and power lines on Thursday, Oct. 6. Completion awaits electrical connections to a meter post.



To facilitate the pump installation, contractors sprayed algae that covered most of the pond surface. Aeration will improve water quality and clarity. Treatments twice a year will maintain the pond and help prevent a new algae mat.

## Dam update

Let's try this again. In association with Herculaneum, the dam at Stonewater's lake has been improved to cover the subdivision's main water and sewer lines. Those pipes were exposed after July 2's rainstorm.

Shown at right, the site now has a wider, sloping cap. Underneath, a third wall was built to prevent water from washing away fill material around the pipes. Metal rods connect the cap and walls. Stonewater and Herculaneum split the cost 50-50.



The dam failed several times at the same location, the narrowest part of the structure. Previous repairs included rock and earthen fill. The flat cap was installed last year. The pond holds runoff from Stonewater storm drains.

# Pet project

Herculaneum requires licenses for dogs and cats. Licenses are available via mail or in person at Herculaneum city offices, 1 Parkwood Lane. Cost: \$5 per pet, payable with cash or check. Requirements: Owners must provide proof of rabies vaccinations. Did you know Herculaneum limits pets to four per household?

Please control dog barking. Complaints could result in a subdivision violation.

# Last word

As a reminder, Stonewater is in Herculaneum, which provides water, sewer, trash and police services. City regulations apply if not covered by Stonewater HOA covenants, which all homeowners are under legal obligation to follow if homes were purchased after Nov. 4, 2011.

Stonewater is not in the city of Pevely. It is in the Pevely ZIP code that was established long before Herculaneum annexed the subdivision.
